### The Foreword

Within, two years SDN Somali Disability Network has made progress. Established the end of the 2022 with vision of merging the diverse OPDs scattered in the country in a single network and strengthen their capacity for organizational management, coordination, program implementation, partnership and accountability has made progress. Within the 15 members OPDs members the network. SDN has joined international networks and alliances for civil society and disability.



Currently there are five schools that provide formal education for the visual and hearing impairment student in public private schools hosting nearly 555 students. And 3 non-formal education schools which provide TVET technical vocation education training for the youth and the adults with disabilities mainly the physical challenged. And some class of literacy and numeracy for the adult people all these institutions came with vision from PWDs who realized the gap in the sector and the need in the society.

After 1991 collapse of the central government Somali public and private infrastructures destroyed the service providers lost in the civil war. New revolution of Civil society wakeup 1992 that that made progress in one decade and restored public private sector in Somalia. The rights and the role of the disability people dwindled. A nation of disability rights wake up in the early the nineteen which made progress and now operational.

Somalia federal government signed the CRPD the united convention rights persons with disabilities which his national law with an obligations to the decision makers in Somalia the CSOs, International Donors, the federal states and federal government of Somalia. And the establishment of NDA National disability Agency 2018 governmental agency mandated service delivery in the federal government Somali constitutions.

Therefore, SDN appreciate the position in the CSOs in Somalia with partnership of donors primarily the Save children Somalia, UNSOM HRPG and the HI that work with OPDs partially as sub grant or indirect implementers. Most of the DPOs member the network acknowledge the role of the Abilis Foundation and AET who made support the DPOs and PWDs. Most of the DPOs are in gap not supportive and service delivery. DPOs represent for more than 20% who invisible without rights and role in the society.

We acknowledge the international donors who made their best the support for million people in the disaster in the last three decades. This has made possible the protection of many people mostly the women and children and elderly people. With human rights protection, humanitarian development and the state build Somalia that enabled the foundation major public institutions that provided service for the IDPs camps and the civilians.

SDN has made extensive effort to improve the capacity of the network the first year 2021 with partner of teams and donors who made possible the capacity injection for the member organizations and the network office teams. This has made progress in the second year 2022 which is achieved the more achievement

SDN secured the partnership with donors local and international and members of the government organs including the NDA National Disability agency. SDN has worked the different programs supportive for the PWDs. Inline the 2022 strategic plan the guide for the programs. And the implementation the administration system which is made strong the coordinate and manage small and intermediate programs in the near future.

SDN has made program the IE inclusive education for the schools and institution providing formal education for the children with sensory impairment in inclusive school. Somalia Disability Network is established in Somalia on Tuesday 06 October 2020 in Mogadishu by a group of Somalia PWDs persons with disabilities who are mostly actors of the DPOs the disabled people organizations and activist groups working the disabled people advocacy and empowerment

After three month consecutive consultation meeting that stared august 2020 in workshop organized by the save children UK training advocacy raising and the establishment of the DPOs network in Somalia with support the leaders and actors of the PWDs and DPOs

In September temporary committee was established for the process of the consultations the best network DPOs and PWDs can help them unity and empowerment in the Somalia civil society.

After week the team proposed the establishment Somali disability network with membership from the PWDs and DPOs as well as service providers and stakeholder working the issue of the disability in Somalia. On October the first week the temporary committee managed the membership fee collection from 15 DPOs who paid cash money for the membership fee and the ToR of the Somali disability network has been finalized and passed two readings in front of the majority of the representatives from the member organizations Somali disability network

Tuesday 06 October 2020 the first meeting was held where participants voted for the election of the assembly very interesting work that served nearly one hundred with huge challenges against the achievement of the goal of the team and the PWDs persons with disabilities.

The event is organized jointly SDN Somali Disability Network and the SEIN Somali Inclusive Education Network. # ZERO Tolerance FGM Against Disability Girls

SFDI organized FGM prevention from the disability girls and women On Tuesday 05 July 2022 SAFDI conducted panel discussion for the prevention of the FGM against the women young girls with disabilities. The workshop is held in Mogadishu participated females from CSOs, PWDs and the community. The panel disunion is participated key activists for human rights and particularly gender rights protection.

The workshop is participated 40 persons who made their participation in the decisions. Five key questions were debated in the meeting and the challenges were raised in the argument that emphasized the negligence of the disability women rights protection in Somalia.

Women and girls with disabilities are more vulnerable in the society and mostly victim of the GBV that are not reported usual in the human rights and public in the media The topics raised in the panel disunion

- 1. what is FGM and its legal or illegal?
- 2. The impact of the FGM in the society
- 3. What are the legacy short and long time?
- 4. How can FGM be reduced in the society?
- 5. What is required to fight against FGM?

The panelist analyzed the root causes of the FGM in the society. And the impact of the social for the young girls. And the role of the practitioners who are the main facilitators of the FGM.

The pianist has also readied the importance of legislation the can prevent the FGM Mass awareness and advocacy in the society that can raised the impact of the FGM in the society mainly the parents and the key leaders of the community realize the illegality of FGM

the workshop the training hall and equipment that made possible the achievement of this activity. SONAD is deaf school that serve for more than 350 students in three schools based in Mogadishu.

The workshop was jointly coordinated collectively SONAD Somalia National Association for the Deaf, SUB Somali Union for the Blind, SDPDO Somali Disabled People Development Organization, ACSOS Action of Somali Social Workers and SAFDI Somali Association Female disability most of the participants came from these organizations. The members of the executives of these three organs that host number of organizations and member groups working the advocacy and inclusion for all in the country

The press statement

- The PWDs complain about people who are working corruption against the disabled people rights in Somalia with the vision monopoly the right of the PWDs.
- the PWDs declare there is high level of public and private exclusion the PWDs and misuse of their resources that can be corruption without accountability
- the DPOs recommend the international community and the donors should work the inclusion of humanitarian and development investment programs actively with participation of the PWDs

and the DPOs the decision making in the initiation, planning and the implementation

- PWDs demand accountability of all GBV and VAW against the voiceless young girls and women with disabilities
- PWDs react the discrimination of the PWDs the employment of the partnership programs inclusion for the CSOs for the disability people
- PWDs call zero tolerance for the corruption against the disability people and their resources in Somalia the private and the public sector.
- The PWDs and the DPOs jointly call to the CSOs, donors and government institutions extend the PWDs and the DPOs accessibility, equality and equal opportunities

The meeting will have agenda to map out the need and the problems from disability and the solutions the problems. The meetings will two days which separate activities.

one the meeting will be introduction, panel discussion and questions and answers for the situation of the disability people in Somalia. The chairperson Somali disability network AbdullahHussein Osman made welcome of the participants with brief explanations disability people and their organization and the advantage global disability submit commence 2022 and the ministry of women and human rights Mrs. Hanifa Mohamed Ibrahim made remarkable speech in the meeting..

The chairperson of the National Disability Agency committee Mr. Mohamed Jama talked the CRPD in brief and the overall situation of the PWDs in Somalia. And recommended Somalia and international community commitment for the support of the disability who have no even census and strategic plan. So far we finished preparation for the draft report the disability people need assessment.

The panelist discussion six key thematic areas of problems facing the disability people in Somalia. Education barriers, healthcare service, social protection, employment, disasters and so on. The panelist made deeper explanation of the issues and the participants asked question.

The workshop is strengthen the capacity of the SCOs Somalia for clusters in the coordination of electoral work in the country. this program has trained 40 persons both male and female including the disability people.

## THE HOPE FOR THE DEAF CHILDREN IN SOMALIA



Group of deaf founded the organization which runs 3 schools in Mogadishu hosting 35o student from primary, intermediate to secondary school level.

This is one of the hopes for many families who have children with hearing impairments in Somalia. The team has opened much school in the country for the deaf. Currently there 30 school for the deaf people in the country. Most of these schools are established by volunteer who work as teachers and managers. These school don't benefit from the inclusive education funds and the government budgets.

SONAD is one of the organizations members of the SDN network that provides formal education for the deaf. This is a great work that made true for the dreams of many children who are not accessible the public and private schools in Somalia. The students and the schools for the deaf people operate without national sign language in the country. Alternatively most school for deaf people use ASL America Sign Language. An obligation for the rights of the children with disability in Somalia federal constitutions, CRPD and CRC

### THE PROFILE OF THE ORGANIZATION

### **Background Information**

Somali Disability Network (SDN) is a legally registered local NGO. Registered with the Federal Government of Somalia – Ministry of Interior Federal Affairs and Reconciliation. SDN is a nonpartisan Network of Disabled People Organizations (DPOs) established in the year 2020 by a group of Somali Scholars, Intellectuals and Professional most of whom Persons With Disabilities (PWDs).

The organization is focusing on improving the lives and livelihoods of persons with disabilities and promoting respect for their dignity and fundamental rights while working as a platform on matters humanitarian, human rights and development utilizing the Convention on the Rights of Persons with Disabilities and other human rights instruments.

The organization is a 15 plus member organizations majority of which are organizations catering for people with disabilities (PWDs), Service providers and minority organizations across all the regions of Somalia. The organization also assists its multi-disabilities clients and their associates in many different areas. The organization is founded on the principles of democracy, respect for human rights and the rule of law with a strong focus on the vulnerable, marginalized and minority groups in all the regions of Somalia and beyond that have been subjects of oppression, discrimination and marginalization for years.

### SDN Objectives

- To strengthen and union for the PWDs as official groups, organizations and work as network with ownership initiatives and support
- To support the protection of the human rights through the advocacy and awareness for the CRPD implementation in the public and private sectors in Somalia
- To identify people with disabilities who are interested in forming their own organization, and ensuring that there is representation from women and children with disabilities, all impairment groups (especially people with severe or multiple impairments), and people from different socioeconomic groups;
- To support formal and non-formal education programs SNE and IE inclusive vie education program through mainstreaming the public and private education sector in Somalia
- To work in partnership with disabled people's organizations at the national or regional level to organize training workshops to build the capacity of potential local members of disabled people's organizations;
- To assist the PWDs a DPOs strengthen organizational structure, mission, objectives, and plan
  of action; and complete any other necessary legal formalities;
- To provide on-going assistance once the disabled people's organization is formed, e.g. inviting local members to training sessions.

- To advocate the establishment and implementation national disability legislation, bills and policies for social and political participations
- To support the PWDs recreational programs Paralympics games and physical exercise for the health of the PWDs and members of their families

### SDN's membership

SDN's membership is open to any legally registered Not for Profit working in the areas of human rights advocacy, humanitarian and development in Somalia towards an inclusiveness and in accordance with the constitution and the rules of the Network. Every member organization must fill the membership upon payment of a membership fee of USD 100

### **Our Vision**

SDN envisages an empowered in solidarity with people with disabilities and other vulnerable groups across all the regions of Somalia within internationally recognized legal frameworks. To realize our vision of a socially just, accessible, and inclusive community, our purpose is to be a leading organization which values diversity, respect and equality to fully realize the potential of persons with disabilities in order to build a better world for all

### **Our Mission**

SDN's mission to improve the lives and livelihoods of persons with disabilities and promote respect for their dignity and fundamental rights in South Central Somalia while working as a platform on matters humanitarian, human rights and development utilizing the Convention on the Rights of Persons with Disabilities and other human rights instruments

The Network strives to contribute to building, strengthening and supporting PWDs in Somalia to become self-reliant individuals living a dignified life and contributing to the advancement of the needs and wellbeing of PWDs through joint collaborative efforts, advocacy and provision of policy guidance aimed at improving the conditions of PWDs at local, regional and national levels. SDN believes that PWDs should take charge of their lives, rather than depending upon others. As a result, SDN intends to create space and meaningful participation for PWDs in all decision-making processes that affect them.

- Goal 4: Enhance public institutions accessibility for PWDs
- Goal 5: Advocate and lobby for inclusive free education for PWD

### Organizational Core Values

- I. Respect to viewpoints: We recognize the importance of considering opportunity to all voices and opinions, including those that contradict our convictions.
- II. Respect of Rights of PWDs: We believe in deliberately strengthening the capacity of PWDs and other minority and vulnerable groups to meet their basic needs and to improve on their position; and have a strong commitment to the rights of the PWDs.
- III. Courage of Conviction: SDN believes in being creative and radical without fear of failure in pursuit of what we believe is in the course of human justice, equality and dignity.
- IV. Fairness, equity and Justice: We strive to ensure that everyone, regardless of sex, age, race, tribe, class and religion, has equal opportunity for expression and for utilizing their unique potential
- V. Institutional Integrity: SDN emphasizes honesty, transparency and accountability to the members, community and to our collaborative partners or otherwise; this is to instil the virtue in which we strongly believe

### **Management Process**

The organization's management is based on a participatory approach, which promotes collaboration with other stakeholders such as the Local Authorities, Non-governmental Organizations and other Community Based Organizations. This collaboration minimizes duplication of development efforts and explains SDN's unique intervention approach. The organization has a pool of experienced, qualified and dedicated staff headed by the Executive Director who reports to the Board of management. We also on project to project basis normally engage volunteers for specific assignments depending on the duration of the project

### **Financial Management System (FMS)**

The organization applies a strong FMS Principle to manage her financial resources. The system has been instituted to safeguard utilization of the organization's resources and ensure appropriate Internal Controls over the financial function which includes Management Information Systems; Custody of assets, Segregation of duties, Approval and Authorization of transactions at different levels of responsibility. With a strong inbuilt Monitoring, Evaluation and Reporting procedures the system facilitates provisions of timely regular reports for all the stakeholders. The financial and accounting policies and procedures are based on International Accounting Standards and maintain a distinct disclosure of Capital, Recurrent, Partners' Designated and Other Funds. Annual external audits are undertaken by an internationally recognized firm of Certified Public Accountants, who issue certified reports to development partners, donors and members

### Rationale and General Approach to this Strategic Plan

SDN's programs and projects are delivered through an empowerment model rather than simply a charity one. Such approach, we believe, is critical for a sustainable development. This is actually being well tested on our current projects in Somalia while trying to support the independence of DPOs and PWDs through investment in small business enterprises, providing access to the necessary medical, legal and economic resources and developing skills-based training programs.

### SDN Strategic Planning Context

Persons with disabilities are defined as those who have long-term physical, mental, intellectual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society on an equal basis with others. In general terms disability can be understood as the human condition that results from an impairment that may be developmental, emotional, sensory, mental, cognitive or physical or a composite of these.

### **Priority Themes Bridge CRPD-SDG2030**



**Goal 4** on inclusive and equitable quality education and promotion of life-long learning

opportunities for all focuses on eliminating gender disparities in education and ensuring equal access to all levels of education and vocational training for the vulnerable, including persons with disabilities. In addition, the proposal calls for building and upgrading education facilities that are child, disability and gender sensitive and also provide safe, non-violent, inclusive and effective learning environments for all.



**In Goal 8:** to promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all, the international community aims to achieve full and productive employment and decent work for all women and men, including for persons with disabilities, and equal pay for work of equal value.

Closely linked is Goal 10, which strives to reduce inequality within and among countries by empowering and promoting the social, economic and political inclusion of all, including persons with disabilities.



**Goal 11** would work to make cities and human settlements inclusive, safe and sustainable. To realize this goal, Member States are called upon to provide access to safe, affordable, accessible and sustainable transport systems for all, improving road safety, notably by expanding public transport, with special attention to the needs of those in vulnerable situations, such as persons with disabilities. In addition, the proposal calls for providing universal access to safe, inclusive and accessible, green and public spaces, particularly for persons with disabilities.



**Goal 17** stresses that in order to strengthen the means of implementation and revitalize the global partnership for sustainable development, the collection of data and monitoring and accountability of the SDGs are crucial. Member States are called upon to enhance capacity-building support to developing countries, including least developed countries (LDCs) and small island developing states (SIDS), which would significantly increase the availability of high-quality, timely and reliable data that is also disaggregated by disability.
